

# MINUTES OF THE MONTHLY MEETING

The March MARAC meeting was held on March 12, 1988 at the Holiday Inn East, St. Paul, Mn. President Don, WAOLKL, called the meeting to order at 9:08A. Also in attendance werw Wonnh, WBOKIN, W9LHG, WOKMH, WAORJJ, WBOUPU, NODRX, and NODXH.

- Q. Can I get the application book returned?
- A. Absolutely. It will be returned as soon as possible.
- Q. What are the minimum requirements to get the FBCA?
- A. The minimum is 1500 Counties confirmed on any one of the five bands.
- Q. Can I get it endorsed CW, YL, Mobile, etc?
- A. Yes each type of endorsement will be separately numbered.
- Q. If I apply for All Counties on One band and 1500 on Another, will the 1500 be processed at the same time?
- A. Yes. Your application will be processed in its entirity determined by the group and the sequence that it was drawn in. (Note: see Feb. N/L for details and application process.)
- Q. I already have USACA All Counties endorsed for All one band, do I have to list all of the counties again for FBCA?
- A. No your USACA All Counties endorsement will qualify you for for the FBCA application if you have received the

- USACA All Counties endorsement from the CQ Awards Custodian.
- Q. What form do I need to apply for the award?
- A. Use the application form from the USACA Record book or use a copy of it.
- Q. Does the \$10 basic fee cover all endorsements on the initial application or do I need the extra endorsement processing fee?
- A. The basic fee covers all of the initial processing.

If you have other questions regarding the Five Band Counties Award, please let me know as spoon as possible. I would like to have everyone that is interested get their application in prior to the May 1st drawing so that everyone has an opportunity to obtain one of the lower numbers. Incidentally, if you are in the area and would like to be present at the time of the drawing, please drop me a note and let me know when you will be here. Maybe if there is interest, we could have a cook-out!

ALTERNATE NET FREQUENCIES.

Occasionally, it is necessary to establish an alternate net frequency to accommodate a large number of mobiles or to eliminate the "backlog". Avoidother operating nets and in-progress QSOs is not impossible, but sometimes made difficult by the eavesdropper. When one looks for an alternate frequency and comes back to the Net Control and announces "14328" as an alternate, you can bet that it will be busy when you return to it. both my fixed-station transmitter and my mobile transmitter when I am not mobiling. One, I keep on 14336, the other, I use to find the alternate frequency. I can listen to the eavesdropper touch-up his transmitter on the alternate I have named. I suggest an alternative method of naming the frequency. It isn't new, its just a practical method. The following diagram may be useful in understanding the system:

Tell the Net Control you are going to Channel 03, or "Channel 3". That means 14324, plus or minus 500hz, depending on QRM. We know that there are nets on 14332 and 14330, so those channels should be avoided for the purposes of living with our neighbors.

#### INFORMATION FOR AMATEUR OPERATORS

#### PROBLEM:

## RECOMMENDED SOLUTIONS:

Harmonics and spurious emissions.

Install a low-pass filter in the antenna feed line, or in the coaxial link to the antenna tuner

or

Install a filter between the transmitter (exciter) and the input to the amplifier. A second filter should be installed at the amplifier's output.

Use of maximum power levels

Conduct tests by reducing your power to determine the effect that reduced power will have on the level of interference. If lower power operations reduce or eliminate the interference, you may wish to consider operating at the lower power whenever possible. This may help restore harmony to the neighborhood.

High gain or directional antenna

The effective radiated power (ERP) of high gain antennas operated at maximum power levels can create a "blanketing" effect. Consider using a non-directional antenna or reduced operating power.

Poor grounds

Ground transmitter to a metallic cold water pipe or a ground rod driven at least 8 feet into the ground. Ground lead should be at least #10 wire, copper ribbon or strap.

Local interference committees are available to help amateurs resolve their interference problems. For assistance in locating a committee in your area, contact the American Radio Relay League, Newington, Connecticut 06111, or the nearest FCC office listed on page 36.

#### COUNTY HUNTER'S OPERATING PROCEDURES

#### 1.0 PURPOSE AND SCOPE

The procedures described here are recommended guidelines only and are not intended to define rules for Net operation. These guidelines cannot satisfy all situations all the time. Good judgment and common sense should always prevail. These procedures also assume full compliance with the FCC rules and regulations.

#### 2.0 THE COUNTY HUNTING PROCESS

2.1 GOALS. Most serious County Hunters work toward the ultimate goal of making a confirmed contact with another Amateur in each of the approximately 3,075 counties in the 50 states in the United States. The basic award is issued by the CQ Magazine at several achievement levels. MARAC also issues a number of related awards.

#### 3.0 CW NET OPERATING PROCEDURES

- 3.1 GENERAL. The procedures on the CW Net are very similar to those on the SSB Net. For members of MARAC, they will find these in the "COUNTY HUNTERS HANDBOOK." For non-members, they can get this literature from The B & B Shop; P. O. Box 850652; Mobile, AL 36685-0652. Just send a SASE and ask for the free Information Packet. Therefore, this section will deal primarily with the differences. The typical operating speed is about 20 wpm, but all stations are glad to slow down as needed. Also, the NCS should not transmit at speeds much above 20 wpm for obvious reasons. It is suggested that the word "NET" be used as many times as possible; i.e., "THE NET HAS JUST RUN K5XYZ/M IN JONES, TX." This will let outsiders know we are running a NET and not just Hams running mobiles. EMPHASIZE NET AT ALL TIMES.
- 3.2 FREQUENCIES AND TIMES. The CW Net meets at 14.066.5 Khz. It can be recognized by its use of the "CHN" (County Hunter's Net) signature. 7.035 Khz is used as a calling frequency for stations that cannot make contact on 20 meters. The Net is primarily a weekend Net. It always meets for an hour or two beginning at about 1400Z on Saturdays. That is when mobile trips, etc, are announced and it is a good time to be on hand. The Net will stay open during the day on Saturday

and Sunday, if there is mobile activity. Also, it is occasionally open during the week for pre-announced mobile trips around 1300Z to 1400Z.


#### RATE CHANGE!

Please be advised that the Mobile QSL Bureau is changing the rates for MRC QSL processing effective immediately. The new rate is 15¢ a card (or 7 cards for \$1.00) — MRCs or QSLs — for all cards (DX, 2nd Time Around or whatever).

We found this necessary because of abuses by some of the previously free processing of personal QSLs and hope that this new structure will be fair to all. We still encourage you to send you personal QSL with the first contact of a new mobile and hope the mobile will return a QSL to you; however, there will be a charge for this service.

Again, we want to remind you that cards should not be stapled or taped together for processing here. We are able to keep the QSLs and MRCs sorted more efficiently that way. In addition, you will find that your MRCs do not on occasion get signed by the mobiler if they are stapled! As the weather and the bands improve, we trust hope you all will get those counties you are looking for! It is time for each of us to think about taking net

control for an hour or two on a regular basis! Try it, you will find you get to know the stations on the net just a little better - and believe me - it is appreciated by all! TRY IT, YOU MIGHT LIKE IT!
