#### Net Operating Tips By Mitch, W4RKV

For a given county being run, is it fair for some of the stronger stations to get two contacts in that county while others who need the county fail to get a contact at all because time expires and the mobile is signed out? Take the case of a mobile team (OM/YL, 2 OMs). The OM is running the county and will routinely respond first to the strong(est) station that he hears, lets say W4RKV. I have a good contact with him, then ask for a contact with the YL. He hands the mike to her, we make contact, she hands the mike back to him for another QRZ. I've now had two contacts in that county while others who just need credit for the basic county, perhaps for the first time, may not get a contact because of subsequent time constraints. I think there are better and more fair ways.

If my XYL were a ham (she is not) and I was running the basic county under my call, I would announce on the front end that she would make YL contacts AT THE END OF MY RUN, TIME PERMITTING. Then I would proceed to work all who just need the basic county, including relays. If this consumed all my allotted time, then those needing a second (YL) contact would have to move us off the net frequency for the YL portion of the run. George and Joyce, KD8HA/HB, use a slight variation of this system wherein those working George indicate they need a YL contact, Joyce makes a running list of these calls, then works them at the end of George's run, time permitting. It works great, for them and the net. The same method could be used for a team where one call is not good for BINGO but the other is.

- 7. Dates of contacts allowed June 14th (0000Z) thru July 2 (2400Z).
- Listing of contacts showing date, etc to K0AYO along with \$2 to cover costs NLT August 1, 1994. Certificates will be printed based on the number of applications received.
